TAB 4

Reports**❖ Mid Region Metropolitan Planning Organization (MRMPO) Staff**

Kendra Montanari, MRMPO Transportation Planning and Technical Services Manager informed the board that MRMPO, in partnership with the FHWA and NMDOT, is putting on an “Achieving Equity in Transportation” workshop on August 23 & 24 in person in the MRCOG board room. The invitation has been distributed to our committees and registration is almost full with 38 people signed up.

❖ Active Transportation Committee (ATC)

Tara Cok, MRMPO Active Transportation Planner, had no reports.

❖ Transportation Coordinating Committee (TCC)

Mr. Montiel presented the pre-obligation and the post-obligation periods for the project development process. Mr. Montiel also explained what the MPO’s role is within the project development process.

Mr. Montiel informed the board that the MPO is required by federal regulations to look at the annual project listing and the obligation reports. The MPO, TPTG, and TCC, review the status of the existing FFY projects and monitor their status up until the “project status update”, which is before the post-obligation period.

Mr. Montiel also informed the board that the FHWA wanted the MPO’s assistance, along with NMDOT, to monitor project inactivity, discuss project issues, and discuss why projects become inactive.

Mr. Montiel concluded by informing the board that projects are reviewed monthly at the TPTG and TCC meetings. Moving forward, a monthly status report will also be discussed at future MTB meetings.

Mr. Montiel stood for questions.

There was a brief discussion regarding the project development process.

❖ Congestion Management Process Committee (CMP)

Willy Simon, MRMPO Transportation Planner, informed the board that the 2017 – 2021 High Fatality and Injury Network (HFIN) which is used to determine areas with the highest crash rates, including crashes involving bicyclists and pedestrians, has been distributed to the CMP for review and will be finalized soon.

❖ **Land Use & Transportation Integration Committee (LUDI)**

Peach Anderson-Tauzer, MRMPO Outreach, and Engagement Planner had no reports.

❖ **Intelligent Transportation Systems Subcommittee (ITS)**

Nathan Masek, MRMPO Senior Transportation Planner, informed that the ITS Subcommittee did not meet in person, but continued to work on ongoing projects, including the update to the ITS Infrastructure GIS, Phase III and IIIa of the Incident Management Plan which includes continued signal retiming along detour routes and the acquisition of supportive signal software to allow integrated traffic operations among the agencies. A contract extension is being sought from the NMDOT since the current contract is set to expire on Sep 30, 2023. MRCOG legal has amended the existing contract, and the MPO will circulate it to the Stakeholders for key signatures.

R-23-12 MTB**

Maintaining the Boundary of the Albuquerque Metropolitan Planning Area (AMPA)

Kendra Montanari, MRMPO Transportation Planning and Technical Services Manager presented the resolution to maintain the boundary of the Albuquerque Metropolitan Planning Area (AMPA). Ms. Montanari discussed the differences between the 2010 and the 2020 census.

Ms. Montanari stood for questions.

R-23-13 MTB**

Adjusting the Boundary of the Albuquerque Urbanized Area (UA) and the Los Lunas Urbanized Area (UA)

Kendra Montanari, MRMPO Transportation Planning and Technical Services Manager presented the 2010 census smoothed urban areas and the 2020 census smoothed urban areas.

Sagert Sheets, MRMPO GIS Manager presented the mapping of the Albuquerque Urbanized Areas (UA) and the Los Lunas Urbanized Areas (UA).

Mr. Sheets explained the adjustments made from the 2010 census to the 2020 census.

Mr. Sheets stood for questions.

There was a discussion on the adjustments made in the Albuquerque and Los Lunas Urbanized Areas along with potential funding changes due to the boundary adjustments.

Action Taken:

Juan Rey Abeita, Isleta Pueblo, made a motion to:

Adjust the Boundary of the Albuquerque Urbanized Area (UA) and the Los Lunas Urbanized Area (UA)

Tammy Fiebelkorn, City of ABQ, seconded the motion, and it passed unanimously on a vote of 20 in favor, and none opposed. See the voting sheet.

DISCUSSION ITEMS

TAB 7

Steven Montiel, MRMPO Program Manager, presented and informed the MTB of a letter that the MPO received from NMDOT CCRB informing agencies of the new certification and training program that would be mandatory for all Tribal and Local Planning Agencies (T/LPAs). The new certification program will require any person responsible for handling federal funds to become certified through the state prior to entering into agreements with NMDOT and obtaining federal funds. The new certification program will be made mandatory after January 1, 2024.

Mr. Montiel expressed the MPO's concerns regarding the new mandatory certification program and explained to the board that the MPO has reached out to NMDOT and the Construction Civil Rights Bureau and asked them to present new certification and training requirements to the technical committees and the MTB, however, those invitations were declined.

Mr. Montiel mentioned the MPO and MRCOG executive management did meet with the NMDOT Cabinet Secretary and their staff on August 14, 2023, to discuss concerns regarding the new certification requirement and to make recommendations to remove the required certification. Mr. Montiel informed the MTB that a new letter would be issued due to the lack of communication and coordination between NMDOT and the MPOs and TLPAs. He also stated that a frequently asked questions document would also be produced to answer outstanding questions that the TLPAs may have regarding the certification requirement. There was no official timeline on when these new documents would be disseminated.

Mr. Montiel also informed the MTB that the MPO generated an anonymous survey to generate feedback on the new certification requirement. The survey was sent to all technical committees, consultants, and other MPOs across the

state. Mr. Montiel presented the survey results from the survey along with the following recommendations:

- MRMPO strongly supports required training.
- MRMPO does not support the required certification/exam.
- MRMPO would like a regional training geared toward District 3.
- MRMPO recommends an update to the *2019 T/LPA Handbook*.
- MRMPO strongly encourages a self-assessment versus an exam.
- MRMPO Strongly recommends that the certification/exam checkbox not be placed in agreements between NMDOT and T/LPAs.
- MRMPO recommends investigating real issues in project inactivity.
- MRMPO recommends better coordination with T/LPA's and all MPOs across the state.

Mr. Montiel concluded by informing the board that the NMDOT will have updates at the next MPO Quarterly meeting on September 18, 2023.

Mr. Montiel stood for questions.

There was a discussion regarding the new certification program.
