**Call to Order**

Jack Torres, Town of Bernalillo, called the meeting to order at 10:03 AM. Roll was called, and the presence of a quorum was noted. The attendance sheet is included in this Action Summary.

**TAB 1 Approval of the September 16, 2022 Agenda**

Steven Montiel, Transportation Program Manager, addressed the MTB Chair to ask authorization to change the order of the Agenda and bring the last item as the first item.

There were no requests from the public to address the Metropolitan Transportation Board.

**TAB 4 Reports**

❖ **Mid Region Metropolitan Planning Organization (MRMPO) Staff –**

Mr. Montiel informed the Board that the MPO posted an internship position, and the goal is to hire two or three interns.

Mr. Montiel also announced that the Call for Projects for the TIP Development 2024-2029 would be sent out by the end of September.

Kendra Montanari, Transportation Planning & Technical Services Manager, informed that the Safe Streets for All Grant was finished in collaboration with the Safety Working Group. The non-motorized count programs will be expanded throughout the region, and they are also looking into updating the technology. Ms. Montanari also informed that the Land Use & Transportation Integration Committee (LUTI) would start reconvening with the leadership of Peach Anderson-Tauzer, MRMPO Outreach Transportation Planner.

❖ **Transportation Program Technical Group (TPTG) and Transportation Coordinating Committee (TCC)**

Mr. Montiel mentioned that TPTG and TCC took place, and both recommended bringing all the items on the MTB September Agenda before the MTB.

❖ **Active Transportation Committee (ATC) –**

There were no comments or updates.

❖ **Congestion Management Process Committee (CMP) –**

Willy Simon, MRMPO Transportation Planner, mentioned that he will present the Project Selection Process at today's meeting to get the recommendation from TCC to bring it before the Metropolitan Transportation Board. Mr. Simon didn't have any other updates.

❖ **Intelligent Transportation Systems Subcommittee (ITS) –**

Nathan Masek, MRMPO Senior Transportation Planner, informed that they are working on extending the Incident Management Plan contract for another year. They are waiting on a couple of signatures from Bernalillo County and the City of Albuquerque.

## ACTION ITEMS

**TAB 5 - R-22-12 MTB**

**Recommended Dissolution of the Community Engagement Committee (CEC)**

Tara Cok, MRMPO Senior Planner, gave a background of the Community Engagement Committee and explained the reasons for asking for the dissolution of the CEC. The Charter for the CEC was passed by the Metropolitan Transportation Board (MTB) in 2019. The Charter needed revisions and was brought before the MTB in 2021. Still, the MTB members decided that the CEC was not an effective way to perform outreach and decided to defer the vote to pass the CEC Charter revisions until the MRMPO hired an Outreach Transportation Planner. Peach Anderson-Tauzer has been the Outreach Transportation Planner since early 2022 and has researched effective ways to conduct outreach. The MRMPO staff would like to dissolve the Community Engagement Committee and focus on new strategies.

Debbie O'Malley, Bernalillo County, asked about other avenues to engage the community. Mr. Montiel clarified that the Charter for the CEC had the purpose of overseeing the MRMPO outreach efforts. It will be more effective to go directly to the agencies and bring the information to them through the Outreach Transportation Planner. Ms. Cok added that the new way of engaging communities would be more efficient and productive, and methods will be geared toward a hybrid meeting and social media to reach more communities.

**Amending the FFY 2020-2025 TIP To Accommodate Changes**

Claudia Patricia Merlo, MRMPO Transportation Planner, presented the projects included in the 4th Cycle TIP Amendment. There were no questions from the TCC members.

Patrick Montoya, Bernalillo County, asked why deleting the Rio Metro/AMPA Wide Bike Share Project. Tony Sylvester, Rio Metro RTD, responded that Rio Metro decided not to pursue the Bike Share Project due to structural changes in the bike share industry in recent years. He went on to note that Rio Metro views shared micromobility, which includes scooters and e-bikes, as a valuable part of the transportation system and offered Rio Metro's assistance to any agency pursuing this program.

Tony Sylvester, Rio Metro RTD, seconded the motion and passed unanimously on a roll-call vote of 20 in favor and none opposed. See the voting sheet.

**Adopting Revised MRMPO Project Selection Process (PSP) for the Albuquerque Metropolitan Planning Area (AMPA)**

Willy Simon, MRMPO Transportation Planner, presented the final Project Selection Process (PSP) revision. Mr. Simon mentioned that the reason for having this tool is to screen various projects that need funding when funding is not enough for all. He also illustrated how the PSP aligns with the National Transportation Goals.

Mr. Simon compared a project scored through the old process vs. the new PSP. He mentioned that the weight for the scoring items is equally distributed because the MPO considers all factors important. This new selection process has elevated Equity, Environmental Resiliency, and Safety compared to the previous selection process.

Mr. Simon explained that the project score is only one facet of creating a project list, and the MRMPO will create staff recommendations that may not precisely follow project scores. The project presentations will be made to TPTG to collaboratively generate the project list for the new Transportation Improvement Program Development.

Councilor Tammy Fiebelkorn, City of Albuquerque, asked a question related to the Environmental Resiliency Strategies and electric buses used in the old process 2018 PPP vs. the new process 2022 PSP) for the University Bus Rapid Transit Project. Her concern was that the project should receive additional points for having electric buses, which the comparison of the processes/scores did not appear to show. MPO staff assured the councilor that electric buses would score higher due to the increase in points for 2022 environmental

criteria and the addition of climate strategies, tree canopy points, air pollution mitigation points, and natural environment points that the project would score higher in the new system.

**Adopting Revised Transportation Improvement Program Policies and Procedures For The Albuquerque Metropolitan Area (AMPA)**

Mr. Montiel reviewed the revisions made to the TIP Policies and Procedures. For this version, the most significant changes are making a clear distinction between a formal amendment vs. an administrative modification to a project. This update occurs every four years. Information from the Bipartisan Infrastructure Law, and updated page 36 based on a recommendation made by the TCC Chair, Richard Meadows, which is:

- *MPO staff may propose alternative TIP project scenarios based on the high PSP-scoring projects while balancing available annual funding. TPTG members will discuss scenarios and may propose revisions to projects included in scenarios. Once TPTG members reach a consensus on a recommended scenario, the draft TIP may be forwarded to TCC for their review.*

Mr. Montiel briefly talked about the timeline for TIP Development and informed that the number of days to submit a project had been extended from 60 to 90 days; the deadline moved from the end of November to the end of December 2022. He emphasized the importance of the lead agencies' performance but made clear that to receive and accept project proposals, the MPO cannot discriminate. The adoption of the new TIP development is scheduled for July 2023. The timeline will be posted on the website.

Mr. Montiel also informed the existing 2023-2025 TIP would be reviewed in October 2022.
