Public Comments

There were no requests from the public to address the Transportation Coordinating Committee.

Reports

❖ Metropolitan Planning Organization (MPO) Staff –

Steven Montiel, MRMPO Transportation Program Manager, informed the Committee that there were no comments from staff.

❖ Active Transportation Committee (ATC) –

Tara Cok, MRMPO Active Transportation Planner informed that ABQ RIDE and their consultant, Toole Design, gave the committee a presentation and update on the February meeting on Phase II of the ABQ RIDE Forward Network Plan. The results of the first phase of their outreach were shared, as well as an online map that allows viewers to compare the different transit network concepts that have been developed. The project team released a survey to gather input on the potential network concepts, and it can be access at:

The ATC's next scheduled meeting is in April 2023. In the meantime, several Committee members have been participating on the MRMPO Non-Motorized Counts Project Steering Committee. That steering committee will be meeting in early March 2023.

❖ Congestion Management Process Committee (CMP) –

Willy Simon, MRMPO Transportation Planner, reported that the committee reviewed a survey on the future direction of MRCOG's Transportation Analysis and Querying Application. The committee agreed to a set of time ranges that will be used in the updated Transportation Analysis and Querying Application (TAQA)

The CMP Chair led a conversation on roadway access policies and how to manage access on roadways that are meant to be limited access. The committee agreed to allow MPO staff to research the relationship between roadway access and crashes.

❖ Intelligent Transportation System Subcommittee (ITS) –

Nathan Masek, MRPO Senior Transportation Planner, informed that the ITS met in February to review the project proposals for the FY24-29 TIP. The criteria include the evaluation of all projects for inclusion of ITS elements, the association of those project elements to ITS Services, and Service Packages included in the AMPA Regional ITS Architecture. This effort is being conducted by the committee in support of TIP development, and the information will be reported to the TPTG.

❖ Land Use & Transportation Integration Committee (LUDI) –

Peach Anderson-Tauzer, MRMPO Outreach, and Engagement Planner, informed that the LUTI Committee met in February to discuss the Transportation Improvement Program (TIP) and the Long Range Transportation System Guide.

Mr. Montiel provided a walkthrough of the MRCOG website and the TIP webpage to LUTI members where he discussed the funding sources for projects and the proposed projects that are currently posted for public comment. The projects in the TIP are important for the scenario planning committee for land use and transportation integration.

❖ **Transportation Program Technical Group (TPTG) –**

Mr. Montiel mentioned that TPTG reviewed the FFY 2023 2nd. Cycle TIP Amendment and recommended bringing it before TCC.

He also mentioned that the Technical Group continued with the TIP Development 2024-2029 Project Presentations and revised the Status of FFY 2023 TIP Projects and the FFY 2023 Inactive Project Listing as well.


