Reports**❖ Mid Region Metropolitan Planning Organization (MRMPO) Staff**

Steven Montiel, MRMPO Program Manager, informed the board that the TIP Scenarios have been posted for thirty days for public comment and review, and it will continue for another thirty days, for a total of sixty days.

Mr. Montiel also informed the board that the MRMPO will be attending the MPO Quarterly meeting in Farmington, New Mexico and during the MPO Quarterly meetings, the MPO coordinates with all the State MPOs, along with the El Paso MPO and NMDOT. Mr. Montiel explained that the upcoming items from the planning procedures manual are reviewed during the MPO Quarterly meetings, to ensure the planning process is being fulfilled for the entire state of New Mexico.

The next MPO Quarterly meeting will be hosted in Santa Fe, New Mexico in September or October.

Kendra Montanari, MRMPO Transportation Planning and Technical Services Manager gave an update on the following committees and ongoing work:

The MRMPO hosted an annual Tribal workshop on June 7th. The MRMPO highlighted federal funding opportunities and technical assistance tools offered at the MRMPO such as GIS and mapping resources.

The MRMPO hosted a Pedestrian Design for Safety workshop in May, the Twenty-third through the thirty-fifth, in partnership with UNM's local technical assistance program. The training was facilitated by the FHWA and centered around the safe systems approach. Multiple member agencies were represented.

The RTSAP update process is underway. The MRMPO is still accepting representatives from our member agencies to sit on the technical team, anyone interested can contact Kendra Montanari. Kendra Montanari will also be reaching out to the steering committee, and the MRMPO will host a joint meeting of the technical team and steering committee to present the plans moving forward.

AMPO announced their Save the Date for their Planning Tools & Training Symposium, which will be held in Albuquerque next May, the sixth through the ninth, at the Hotel Albuquerque at Old Town. As the host, the MPO would like to offer members an opportunity to showcase an innovative transportation project for one of the mobile tours. If anyone has an interest, please contact Kendra Montanari.

Tammy Fielbelkorn, City of ABQ, asked Kendra Montanari for clarification on the date and time for transit ideas and if anyone has ideas, should they e-mail them?

Kendra Montanari informed the board that the conference will be held on May sixth and go through May ninth. Anyone with ideas on topics is encouraged to e-mail them to Kendra.

❖ **Active Transportation Committee (ATC)**

The next meeting of the ATC Committee will be on June Twenty-Third.

The agenda includes an E-bike legislation update and discussion. Along with the CABQ Parks and Recreation, and the MRMPO Long Range Bicycle System Map. There will be an Initial discussion in preparation for the upcoming major LRBS update.

❖ **TPTG**

Steven Montiel, MRMPO Program Manager, had no reports at this time.

❖ **Transportation Coordinating Committee (TCC)**

Steven Montiel, MRMPO Program Manager, had no reports at this time.

❖ **Congestion Management Process Committee (CMP)**

The CMP met last month and discussed two topics: The TAQA tool was demonstrated and is now live on the MRCOG website. Along with a debrief on the PSP process, which was a year-plus effort used to inform the newly proposed TIP. The CMP had positive feedback on the revamped web portal, project submission, and selection process.

❖ **Land Use & Transportation Integration Committee (LUDI)**

The next LUDI meeting is on June twenty-eighth and the topic will be shaping the goals of the 2045 MTP.

❖ **Intelligent Transportation Systems Subcommittee (ITS)**

Nathan Masek, MRMPO Senior Transportation Planner, had no reports at this time.

Forest Replogle, Transportation Planner, informed the board that the MRMPO is purchasing a package of GIS data features that will be freely available to member governments. It will use trained AI models to analyze ortho-photography datasets and to identify and digitize geographic features. This package will include sidewalk centerlines with width, driveway polygons, and intersection details. Also, dimensions, number of lanes, and type of traffic control.

R-23-09 MTB**

Amending the FFY 2020-2025 TIP (3rd Cycle TIP Amendment)

Steven Montiel, MRMPO Program Manager, presented to the board a summary of the FFY 2020-2025 TIP Amendment (3rd Cycle) which was previously reviewed by the TPTG and TCC committees.

Steven stood for questions.

Councilor Stuart Murray, Village of Corrales, regarding the Electrical Vehicle Charging Network Expansion with the City of Albuquerque Aviation Department, Mr. Murray

asked about the placement of the electrical charging stations and if the parking will be short or long-term. He also asked if the charging stations will be for public use only or will the Aviation Department have electrical vehicles for these charging stations. Lastly, Mr. Murray asked why this specific type of charging station is being installed.

Steven Montiel, MRMPO Program Manager, informed the board that he will find out through the Aviation Department who the project lead is, and he will follow up on Mr. Murray's questions.

Ron Abramshe, SSCAFCA, asked if the different types of charging stations were known at this time.

Steven Montiel informed the board that he is not aware of that exact information, but he will look into it more.

Jill Mosher, NMDOT, wanted to clarify the description for the Rio Bravo project. Ms. Mosher mentioned that the NMDOT received a request from the FHWA, to change the scope description for Rio Bravo from "structurally deficient" to "bridge replacement".

Chair Klarissa Pena, City of ABQ, asked Steven Montiel if an amendment was necessary to remove the Rio Bravo description from the TIP Amendment.

Steven Montiel informed the board that an amendment would not be necessary, the Rio Bravo description can be changed on the administrative side. The MPO will make sure that it's in the final amendment that gets sent to the State.

Review of Upcoming Agenda Items for July:

- ❖ Adoption of the FFY 2024-2029 Transportation Improvement Program

Steven Montiel, MRMPO Program Manager, informed the board that the MPO is looking for the final adoption of the TIP that was presented last month. Mr. Montiel explained that one thing will look different in the TIP Amendment. The scenarios that were presented will be included; however, it will also include everything that transferred over from the current TIP into the new TIP.

The next TIP will be 2024-2029, and it will also include all of the FTA funding. A detailed attachment and summary will be provided that will incorporate every project and fund source.

Mr. Montiel also informed the board that the Adoption of the AMPA boundary will take place in August and September. The MPO will be looking at the update on the smoothing of the Urbanized Areas, along with a review of how the areas have changed and any anticipated growth in the next twenty years.

Steven Montiel stood for questions.

Jill Mosher, NMDOT, asked for the final summary for the Covid Relief Funds.

Steven Montiel informed the board that the White House and Senate passed a Debt Ceiling Bill. Mr. Montiel explained that any Covid Relief Funds that were unobligated and programmed in the outer years, would be swept away with the passing of that Bill.

Mr. Montiel informed the board that a meeting was called with the agencies impacted by the passing of the bill. The MPO, along with the State, and the NMDOT came up with a proposal to hold the projects harmless, by utilizing old surface transportation large urban funds.

Ron Abramshe, SSCAFCA, asked for clarification on the covid relief funds situation before the debt ceiling bill (debt relief).

Steven Montiel informed the board that in February and March of 2021, the MPO received eight million dollars in covid relief funds. Mr. Montiel explained that some of the funds were programmed in 2021-2022, but that the MPO had followed the TIP, and most of the funding was programmed in 2023-2024.
