1. 2010-2012 data were revised based on 2012 AMPA Boundary expansion
 2. Data are based on 3-Year count cycle, thus providing a tempering affect on near-term trends
 3. Southern Sandoval Co added to Federal Aid Urban (FAU) in 1982.
 4. VMT for 1970 to 1976 was for the Albuquerque Transportation System (ATS) area. That area included Corrales, but excluded Rio Rancho. The ratio of VMT for the FAU to that for the ATS for 1977 and 1978 was used to adjust the ATS data to correspond to the FAU.
 5. Miles of roads are for FAU except 1970 and 1971, which are ATS.
 6. Due to various data issues, these data are best used for observing overall changes and trends, rather than analysis of individual years.
 7. In 2001, the AMPA was redefined to include all of Bernalillo County and southern Sandoval (pop data for same area in 2000 was 622,314). The 2000 data in the table is 2000 Census data.
 8. In 2003 a new methodology resulted in an increase of 800.3 miles of urban local roads and 229 miles of rural local roads from prev year.
 9. 2016 and later, roadway functional classification was updated to that of the NMDOT in coincident with development of their linear referencing system.
 10. 2018 Population is based on a simple estimate and should be consider preliminary
